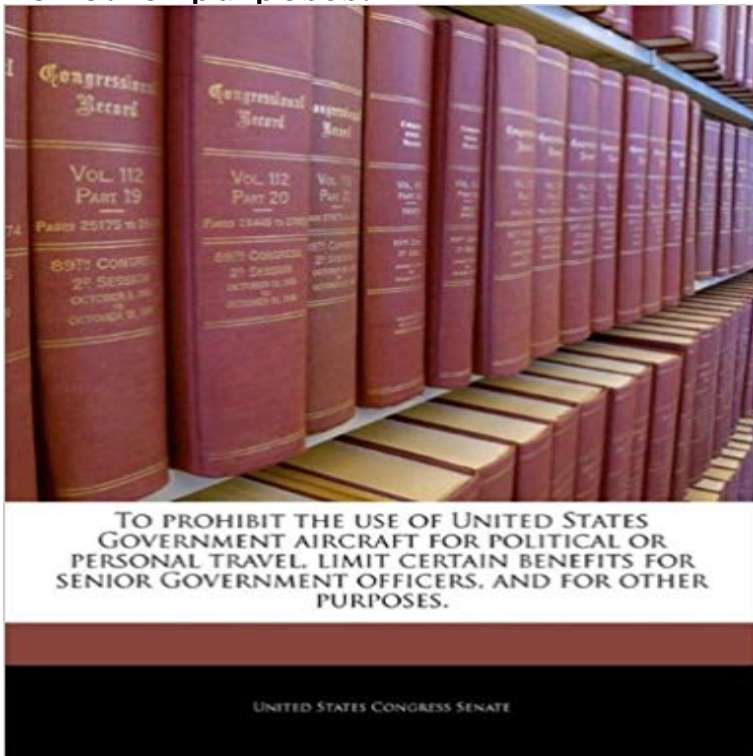


To prohibit the use of United States Government aircraft for political or personal travel, limit certain benefits for senior Government officers, and for other purposes.
